



### Are your clinicians and contractors cleared to provide service?

Pennsylvania State and the Federal government mandates that all staff involved in providing billable services be checked against three databases:

- List of Excluded Individuals and Entities - LEIE
- System for Award Management – SAM (formerly EPLS)
- Pennsylvania State Medichex database



About 1 % of agency staff names will show on a report against the three databases because the names are similar to an individual excluded at the State or Federal level. They must be checked manually. Staff exclusion reports are provided as part of eligibility5010. These reports are also as a separate application. The sample report below shows how easy it is to match up the staff.
